9- Brownlow - Biker/ Hiker incidents - a hiker has been putting logs and rocks in the trails in blind spots on the trails to try to keep bikers off. There has been a guy out there yelling at bikers as well. FS and Chris at the City has been alerted to this and investigating.

PMBA has the Fall Festival coming up Oct 14th, Halloween Ride on Peavine, and Turkey Day Ride at 396.

YTA - has grant money for emergency signage along the Circle Trail. This is for emergency services to get into the right spot and for the injured person to be able to tell the responders

where they are. Like road Mile Markers. YTA wants feedback on where we think people get lost the most and what causes people to get lost, how many and how far apart should the signs be.

Derek from PGTC - Prescott Gravity Trails Coalition - he represents the Down Hill, gravity trails, directional trails/ flow trails - users group. He just wanted to let PTSC know there is a group out there but they want to make sure the trails are safe for other users groups but to say there is a need for these types of trails. He is making sure PTSC is good with them pursuing getting trails built that would be representative of this type of design. He said that with the new group it should help stop illegal trail building from happening.
